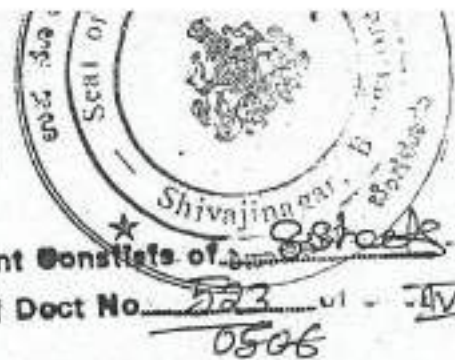

R.Sadagopan**, and **Smt.S.Rajalakshmi** are chosen by the AUTHOR to execute the intentions and philanthropical commitments by falling in line under the Authorship of Sri.K.Kuppuswamy during his lifetime and continue to strive for the noble cause after his demise through this Public Charitable Trust. Sri.R.Sadagopan, S/o Sri.J.Rajamani, aged at 52 years, and residing at 48, Miller Tank Bund Road, Bangalore 560 052, and Smt., S.Rajalakshmi, W/o Sri.R.Sadagopan, and aged at 43 years and residing at 48, Miller Tank Bund Road, Bangalore 560 052 will be the **LIFETIME TRUSTEES** for the abovementioned Trust.

03.3 However, the non appointment of a Trustee against vacancy shall not invalidate the Trust or any action taken or done on behalf of the Trust. However, all vacancies caused in the Trust shall be filled at the earliest .

04. OFFICE BEARES OF THE TRUST:

04.1 MANAGING TRUSTEE:

The Trust shall have a Managing Trustee who shall be elected from and amongst the First Trustees of the Trust. The First Managing Trustee of the Trust shall be Sri.K.Kuppuswamy. He shall hold office until his lifetime. After his lifetime, the next Managing Trustee shall be elected from and amongst the remaining First Trustees of the Trust. The Managing Trustee shall have the responsibility to conduct and chair the meetings of the Board of Trustees.

04.2 TRUSTEES:

Mr.R.Sadagopan, and Smt.S.Rajalakshmi are the First Trustees of the Trust, and they will be the lifetime Trustees of the Trust. In the event of a vacancy caused by the death of anyone of the First Trustees, such vacancy shall be filled only by appointing a suitable person from among the family members of First Directors, and in the case of nonavailability of such a person, any other person as the First Directors/remaining First Directors deem fit and eligible to carryover the responsibility in the most befitting manner.

04.3 Secretary:

The Trust shall have a Secretary and the first secretary shall be Sri.S.Natarajan. He shall hold office for a period of one year initially and thereafter the next Secretary shall be elected by the Trustees from any eligible person at their discretion. The retiring Secretary shall be eligible for reappointment at the discretion of the Trustees.



Mr.S.Natarajan shall have the overall responsibility for the day to day administration of the affairs of the Trust.

4.4 Treasurer:

The Trust shall have a Treasurer who shall be appointed by the Board of Trustees and Mrs.Gayatri Varadarajan shall be the first Treasurer. She shall hold office for lifetime.

The Treasurer shall have all the responsibilities of opening and maintaining all the bank accounts of the Trust as per the instructions of the Board of Trustees.

The Treasurer shall have also the responsibility of presenting Annual Reports, maintaining of proper accounts of the Trust on Annual basis in accordance with the Fiscal year beginning from 01<sup>st</sup> April and ending on 31<sup>st</sup> March.

The Treasurer shall interact with the Trust's Auditors for preparation of Annual Accounts and any other bank matters after concurring with the Trustees.

04.5 Advisory Committee:

The Trust shall form such committees both adhoc and standing depending upon the needs of the Trust as it evolves in the growth process of the Trust. The Secretary of the Trust shall have the responsibility to convene the meetings of these committees and also present their advice to the Board of Trustees for their approval.

05. Powers of the Board of Trustees:

- 05.1 The Trustees shall hold the properties of the Trust for the Objective clause stated herein.
- 05.2 The Board shall have the power to receive gifts, donations and Contributions in cash or in kind from individuals and organizations, both National and International, from within the Country and abroad to promote the objectives of the Trust.
- 05.3 The Board of Trustees are entitled to appoint Chartered Accountants, Legal Advisors, and such other professionals on Such terms and conditions as the Board of Trustees may Deem fit from time to time.

- b. Sri R.Sadagopan, s/o Sri J.Rajamani, aged about 52 years and residing at No.48, Miller Tank Bund Road, Bangalore 560 052.
- c. Smt.S.Rajalakshmi, W/o Sri.R.Sadagopan, aged about 43 years and residing at No.48, Miller Tank Bund Road, Bangalore 560 052.








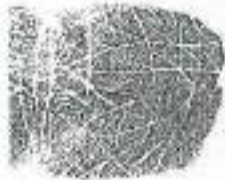
- 05.4 The Board of Trustees are entitled to file law suits on behalf of the Trust and defend any action taken against the Trust or come to a compromise and compound such cases.
- 05.5 The Board of Trustees shall have the power to acquire the capital assets to meet the objectives of the Trust and also to dispose them off to raise loans and pay interest.
- 05.6 The Board of Trustees are authorized to sell, lease, mortgage or otherwise deal with any of the properties of the Trust both movables and immovables.
- 05.7 The Board of Trustees are authorized to invest the funds of the Trust in accordance with the provisions of the Income Tax Act of 1961 as amended from time to time and the rules made thereunder.
- 05.8 The funds of the Trust shall not be directly or indirectly made available to the authors of the Trust or other persons mentioned in Section 13 or such other amended provisions of the Income Tax Act 1961, so as to directly or indirectly benefit such persons referred therein except for payments for expenses or costs incurred for services rendered for the development of the Trust.
- 05.9 The Board of Trustees are empowered to takeover and run any existing institutions or centres for promoting the objectives.
- 05.10 The Board shall be authorized to frame such rules and regulations for proper conduct and administration of the Trust but any such rule shall not be against the objectives and spirit of the Trust or other conditions of this Deed of Trust.
- 05.11 The Board is authorized to enter into agreement with any Government-Central or State and with any authorities- such as local municipal or otherwise and obtain from such Government or authority all rights, concessions and privileges that may be deemed conducive to the furtherance of the objectives of the Trust.

06. INDEMNITY:

Every Trustee shall be indemnified out of the Trust funds against all losses and expenses incurred in the discharge of his/her duties, except such as shall happen through his/her own neglect willful act, or default and each Trustee shall be chargeable with only such money or property as he/she shall himself/herself receive or in the

07. MEETINGS OF THE TRUST:

7.1 Annual General Meeting

The annual General Meeting of the Trust shall be convened by the Secretary by sending notice to every Trustee in writing after the end of the fiscal year but before 31<sup>st</sup> July of every year. This meeting shall be chaired by the Managing Trustee of the Trust. In the above meeting the following business shall be considered:

- a. The annual audited accounts shall be presented for adoption by the Board of Trustees.
- b. The annual report of the Trust shall be presented by the Secretary.
- c. The auditors shall be appointed to audit the accounts of the Trust for the ensuing financial year.

7.2 Regular Board Meetings:

The Board of Trustees may meet as often as the needs of the Trust demands at the request of the Secretary. The Managing Trustee can request for a meeting and extraordinary meetings can be requisitioned by Trustees not less than 1/3 rd of the total number of Trustees. However, there shall be atleast one Board meeting for every quarter.

7.3 The quorum for the Board meeting shall be atleast one third of the total Trustees and for the annual general meeting it shall be atleast one half of the total number of the Trustees,

7.4 As much as possible all decisions shall be taken with consensus and when not possible the vote of the majority present and voting at the meeting shall prevail and in case of equal division the Managing Trustee shall having a casting vote.


